Pegasus: Building an Airplane at San Marin High School



The first question people ask when they learn Villa Marin newcomer Dave McConnell is teaching high school students to build an airplane: "Is it a real airplane and will it fly?" "Yes, it will fly" because Dave and other Marin County Airport (Gnoss Field) pilots donate many hours of instruction for this amazing airplane building program they named Pegasus.

Retired from a career with the telephone company, Dave is also a licensed aircraft mechanic, pilot, aircraft builder, and one-time instructor at Gnoss Field. Recently, he proposed the Pegasus project to a STEM technology program at San Marin High School (SMHS) as high school students need real-world experiences with hands-on projects to prepare them for technical careers. Project-

based learning is one of the most effective methods of teaching.

The STEM program at SMHS is a four-year specialty for students who have an interest in science and technology. In 9th through 11th grades they learn basic engineering, physics, chemistry, biology, and mechanical skills. In the 12th grade they select a significant project, find an expert mentor to help them, and go through basic feasibility and design steps to realize their project. Airplane building is one project, but is unique in that it must be done right. Dave and the other dozen or so pilots helping on this project have each built at least one airplane. The emphasis of the Pegasus project is to enable the students to assume responsibility for the outcome. The role of the adult mentors is to ensure that the resulting airplane will be safe and of high quality construction. This year 21 students, of whom eight are female, are working with the Pegasus project.

The Gnoss Field community has undertaken the financing of this project. The genius is that, once this first airplane is built, it can be sold to pay for the next one. So, eventually, Pegasus will be self-perpetuating.


Elisabeth Stromberg-Baker

Candidates for Villa Marin Board

Five impressive candidates are running for four seats on the Villa Marin Board. The election will be held on January 9, 2018. The candidates were selected by the nominating committee appointed by the Board and chaired by Marilyn Knecht.



Dick Atwood is running to become a Board member because he and Christine want the many great things about Villa Marin to

continue. His business life included plant manager and vice president of a chemical company and later a specialty paper mill, and owner with Christine of a manufacturing company in Richmond. Thus he has experience in management, personnel, procedures, maintenance, and safety. His volunteer work in Marin includes president Mill Valley Tennis Club, president Board of Trustees Community Church of Mill Valley, six years president The Friends of The Redwoods (raises money for The Redwoods Retirement Center), four years president The Redwoods Foundation (raises money to help residents running out of money), five years member the Redwoods Board of Directors. Dick is a good listener who would invite residents to put forth concerns and improvement ideas. He works to bring good solutions to problems, but with an eye to efficiency, cost control and fairness.



Kirk Beales has served on the Board for the past two years and is running for re-election. Joan and he have been at Villa Marin

for almost three years and moved here from Tiburon. His working career was as an engineer with Chevron, where he spent the later years in project cost management. After retiring he served for ten years on the Tiburon Design Review Board. Both his work experience and his time on Design Review help him as a Director here at Villa Marin.



Barbara Heller has lived in San Rafael for over 40 years. She and her dog Lucas have lived at Villa Marin since 2014. Before moving to Villa Marin, she was elect-

ed to the San Rafael City Council for 20 years before retiring in 2013. She is running for her 2nd term on the Villa Marin Board of Directors and has served as President and Vice President of the Board. She plans to continue working towards improvements in the dining room and health center and keep expenses under control. Barbara observes, "I do not take lightly the decisions made by the Board. I know that they directly impact the lives of everyone at Villa Marin. I value highly all the wonderful friendships I have here."



Jerry South is standing for re-election to ensure that several of the changes the Board of Directors have initiated in the past

two years are completed. As a self-governed homeowners condo association, the board is responsible for establishing policies and overseeing management. As Treasurer his monthly responsibilities include review of bank statement reconciliation, reserve account balancing and financial statement review. At least annually he reviews the report of the investment firm that manages the 401(k) employee's account. His personal focus will be on creation of a data retrieval system for maintenance records of the common area and condo units, and adequacy of the property reserve fund. We live in an aging building complex whose history

must be documented and readily available for making decisions that affect the future and the value of our individual properties. His qualifications include practicing law, attending the advanced management program at the Harvard Business School, serving as president of a Bank of America real estate financial and investment company and, most recently, as president of the United States Bocce Federation, a non profit organization.



Spofford's background combines electrical engineering/ computers and marketing. His interests as a Board member

bridge all three. One focus area would be exploring a more strategic approach to how we market Villa Marin. Big changes impact the retirement community market - - older age at entry, fewer second occupants, new for-profit competitors targeting the emerging wave of retired baby boomers. We need to examine our marketing (and maybe our "product" too) to clearly define our advantages vs. our competitors in delivering what these new customers want.

A second focus will be information technology: We will be upgrading our IT systems in the next few years, and Bob could provide valuable liaison between the Board, our IT staff and our outside contractors working in this area. One specific would be to add analysis of trends to the our monthly financial reports. A few graphs would be immensely useful in identifying problems as they emerge and tracking how well we are solving them.
