





Mary was diagnosed with cancer last summer. Her disease progressed rapidly and she eventually became







Mesley Glen Retirement Community


We developed an interdisciplinary team and built a pulmonary rehabilitation program for people with chronic lung conditions to reduce hospitalization and increase quality of life.

In our continuing effort to meet and serve people where they are, we introduced Behavior-Based Ergonomics Therapy (BBET) at Wesley Ridge and Wesley Glen Retirement Communities. BBET is a non-medication-based program designed to reduce and even prevent behaviors associated with Alzheimer's and other dementias.

The BBET program has tools that are available at all times in a resource center located in special care areas. Each resident has a customized memory box that contains special items provided by family and friends that offer comfort and familiarity.

Mesley Moods at New Albany

We broke ground on our newest community on 38 acres in New Albany. We look forward to welcoming new residents!



Mesley Ridge Retirement Community

We opened the Harcum Fitness & Aquatic Center in September 2016. This beautiful facility offers a pool and a variety of exercise equipment and classes. It's a great addition to our community!

We implemented BBET at Wesley Ridge too. We have 30 residents and clients enrolled. It has been a great program to help our nurses and caregivers manage common behaviors. We can usually anticipate a behavior and supply a therapy from a resident's memory box. It works well for boredom, anxiety, and depression.

Wesley Ridge Adult Day Care Program continues to be an important part of the continuum of care at Wesley Ridge. It is housed on the second floor of the English Garden building. In 2016, we served over 42 families (from Franklin, Fairfield and Licking Counties) with a maintained average census of 14 clients per day.

This program affords our seniors and adults with disabilities a safe and secure daycare environment that is supervised by a registered nurse, has dedicated staff to help with the activities of daily living (bathing, eating, etc.), and provides activities to keep them mentally, physically and socially engaged. The program also provides caregivers some respite and allows them to work, attend appointments, or volunteer while knowing their loved ones are safe and well cared for.

The Adult Day Care Program continues to partner with our clients and their families with case management to include the overall health of the client, support groups, education, and links to other community resources should they need them. This year we provided over 3,500 meals; we provided 1,470 transportation services; and had approximately 40 volunteers who put in over 1,700 hours of their time to support the program.

The program receives funding support from the United Way of Fairfield County, the Veterans' Administration, and donations. The Catholic Social Services Senior Companion Program works with our staff to provide companionship to clients.

Mesley Hospice

Wesley Hospice provided care for 85 families during 2016. We offer a wide range of services to our patients and their families including medical equipment, supplies, and comfort medications; 24/7 access to our Hospice team; home visits by Hospice nurse; Hospice aide visits to assist with personal care; social services provided by social worker; counseling and spiritual support for patient and caregivers and much more. We provide four levels of care: Routine Home Care, Crisis Care, General In-Patient Care, and Respite Care.

We strive to make the most of each day for our patients and their loved ones by providing compassion and support, wherever they call home.

Wesley At Home

Sometimes older people encounter challenges in terms of health, routines and priorities. In 2016, Wesley At Home helped 273 such people.

The Wesley At Home team believes graceful aging is fostered by living where and how you want. We offer a cost-effective program that doesn't require our clients to move from their homes. We develop a plan that identifies clients' unique needs and then personalize services to promote wellness, safety and independence wherever they call home.




