Reflections from the Desk of Ferol Labash, CEO

Pinecrest Foundation News

In an endeavor to consolidate efforts and clarify roles and to further support the mission of Pinecrest, the

Pinecrest Foundation Board has made some very significant decisions recently.

For a number of years, having both a foundation (Pinecrest Foundation) and a fundraising department (Brethren Home—Pinecrest Community) has caused some confusion for donors. Pinecrest Foundation has supported special requests from Pinecrest for projects such as the purchase of a handicapped accessible van, partial funding of the parking lot replacement, and other projects for which it has been difficult to realize in our regular budget.

Most recently, due to the continued strain placed on Pinecrest by the Illinois Medicaid system, the Pinecrest

Foundation Board began to consider whether it would be helpful to gift its assets to Brethren Home. At its October meeting, the Pinecrest Foundation Board decided to move forward with this plan.

Pinecrest Foundation will gift its assets including a modest amount of investments, 10 acres of land and the Spirit of Compassion sculpture to Brethren Home. The Pinecrest Foundation Board voted to allow the Brethren Home Board to act on its behalf and the Pinecrest Foundation Board will dissolve. The legal entity of Pinecrest Foundation will remain in place, albeit in dormancy, and can become an active foundation again in the future if it would be beneficial to Pinecrest.

I would like to express my deepest gratitude to current and past members of Pinecrest Foundation Board for their dedication to and support of the mission of Pinecrest Community.

Pinecrest Community Receives Donation from E. D. Etnyre & Co.

Family member Susan Davis spoke passionately about how "Pinecrest provided them with excellent care and allowed each to maintain dignity until the end of their life." Susan herself volunteers regularly in Pinecrest Terrace, and several family members have also worked at Pinecrest.

In making the gift, the Etnyre family and E. D. Etnyre & Co. stated, "We are proud to continue supporting the Pinecrest facilities which have provided so much comfort to our family

members and other community families. With this donation and others, Pinecrest Community will continue their improvement efforts to ensure their ability to provide the best care possible to the local community for many years to come."

As part of our multi-year financial campaign celebrating 125 years of service in Ogle County, Pinecrest is securing financial resources to assist with facility improvements, improve staff support, ensure financial sustainability, and strengthen the Good Samaritan program, which assists residents when their other funds have been depleted or they are in a transition period.

Report from Jonathan Shively, Director of Advancement

inecrest and family go together. The generational and community intersections which Pinecrest nurtures are complex and deep. Rarely am I in a conversation about Pinecrest in which I am not asked about either someone who is a current or former resident or employee, or a member of the Mt.

Morris community. Unfortunately, my roots are "back East" in Pennsylvania, so my knowledge of so-and-so and their family usually requires some learning.

These family and community connections build loyalty and affection for Pinecrest. At a campaign reception in Elgin recently, board member Roger Anna shared a who's who list of people from the Western suburb who eventually made Pinecrest their home. A few of them are there now. Another board member, Patrice Nightingale, shared how much her mom enjoyed her years at Pinecrest, and how through her support of her mom, Patrice fell in love with Pinecrest herself. Generous expressions of Pinecrest's family-community connections show up in lots of ways, such as volunteering and financial support. Recently they emerged in the tremendous gift from the Etnyre company and family described elsewhere in this newsletter.

Gifts like the \$100,000 from the Etnyres are wonderful, and they set the tone for a campaign. They have helped us reach \$428,000 toward our first goal of \$1.5 million by the end of 2019. There have been a few other larger gifts as well, including \$200,000 from the Pinecrest Foundation and nearly \$50,000 from another family with very close ties to Pinecrest. To reach our campaign goals we'll need more of these types of gifts, but we'll also need lots and lots of gifts of all sizes. So if you read those numbers and think, "we might be able to do something similar," great! And if you read those numbers and think, "I can't even begin to conceptualize those amounts," don't let

that dissuade you from asking, "But what can I/we do?" A hundred people giving \$100 each is our next \$10,000!

We are grateful for the generous support of ALL our donors! The fruit of your investment is seen in the lives of our residents, in the connections of family and community, and in the beautiful new parking lot welcoming you to Pinecrest. There is more fruit to harvest!

This event is a great opportunity to do some Christmas shopping and support the Good Samaritan fund.


