Nursing Notes – Focus on Pain Management

Along with the aging process comes aches and pains related to arthritis and other degenerative changes that occur in the body. There are times that other disease processes and conditions can cause much more extreme levels of pain. The overall goal is to keep pain at the most minimal or tolerable level as possible and to meet each resident's goal individually during treatment. Every person has a different pain threshold, and this needs to be considered. It's important for the staff to know what kind of pain management has worked in the past and to try nonpharmaceutical options first.

Some great options to consider are heat or cold compresses, repositioning, and keeping the mind busy with activities of interest. Therapy can offer exercises and other modalities, such as e-stim, for pain management. Other pain remedies include restorative exercise programs, massages, relaxation breathing, music, baths, and topical analgesics applied directly to the area of pain (ie, bio freeze).

Other systemic pain medications may need to be considered for moderate to severe types of pain that are not relieved by interventions mentioned. With pain medications comes the risk of side effects such as drowsiness, GI upset, and constipation just to name a few. The staff will work with the resident's physician to come up with the most appropriate medication regimen and decide if the benefit may outweigh the risk. Frequent adjustments may be necessary along the way.

Another option that is offered at CCRC is Palliative Care. This is an "extra layer" of care that works with the resident's primary care physician to help with symptom management of pain and other conditions. A health care provider that specializes in this area will come to the facility on a routine basis to follow the resident and make necessary changes to help make that resident as comfortable as possible. If anyone would like any additional information on this service, or if you have other questions about pain management please feel free to see me.

I also wanted you to know how proud I was of each of you who happen to be here when the State Surveyors were here in December. They were so impressed by your dedication and your responsible actions during their stay.


