"I was (later) walking to the school bus stop. He came and asked if I wanted to go to a dance on Saturday night," Liz quickly chimed in.

As a the oldest of four, Liz helped her mother with housework and with her younger siblings. She enjoyed competing in 4H (*starting at age 9*), showing cattle and handmade clothing. She won many ribbons at the county fair, and at the state fair in Milwaukee. "I sewed all my own clothes as I grew up," Liz reminisced.

At the state fair, Liz showed dairy cattle. "Some of us would stay with the cattle overnight. Even when I went to

high school, I was still showing cattle, as well as clothing. What I liked best was when it came time to show two outfits at the fair. My girlfriend stayed with me in Milwaukee and we got to model our outfits together. We met other kids from other counties too."

She also won a typing contest using a Royal typewriter in High School. That typewriter is now in a museum in Mt. Horeb, WI. Her typing skills helped land a job as a stenographer after graduation.

Liz and Dale married in July 1956. Dale worked as a truck driver, hauling milk to cheese factories. He later entered the Air Force, and he was stationed at Wiesbaden, Germany for three years. There he worked as a photo interpretation specialist. One of his more significant projects was editing photos taken the by Gary Powers, the famous U2 spy plane pilot shot down over the USSR.

After finishing his tour in Germany, Dale and Liz returned to the US. He

earned his college degree, with Liz taking her old job as a stenographer in Madison to help pay his way through school. They built a home on the same road where Liz grew up, and where they raised two boys. Dale worked as an accountant for an agribusiness firm for 25 years.

In 1993, Liz was diagnosed with Parkinson's Disease. Her doctor said she needed a warmer climate, so they moved to Tennessee. Eventually, they would follow one of their sons who was moving to Louisville in 2012. They found Wesley Manor and moved into a patio home that year. "We were lucky," said Dale. "They had two openings in patio homes at the time. We liked the patio home at that time of our lives. It was just the right size, and we didn't have to mow or shovel snow!"
