#### SUPPORT FOR NORMANDIE RIDGE PHYSICAL THERAPY DEPARTMENT

We are pleased to fulfil our purpose to "enhance the comfort and enjoyment" of Normandie Ridge residents and in our Normandie Ridge Prayer, we ask God at each meeting to bless "our various endeavors for Normandie Ridge as we strive to bring comfort and hope to all our residents who are in pain or distress of body, mind or spirit." The Auxiliary supports all residents of Normandie Ridge through its continuum of

care. Shown here are some of the items recently purchased by the Normandie Ridge Auxiliary for the Out-Patient Physical Therapy Department. Samantha Welsh of the department is demonstrating the cervical traction unit while laying on the therapy table purchased.

Pictured below is therapy patient Michele Markle, with direction from Therapist Alexa Smith, demonstrating the lift box used for strength therapy as weights are added. Pictured below right, Michele is sitting on the Hi-Lo adjustable table as Alexa prepares to use the hawk grips tools for a soft tissue message on Michele's knee surgery scar tissue. Use of

these tools reduces the appearance of the scar tissue and keeps the scar tissue from adhering to the muscles below the scar. The tools are also used wherever a patient experiences tight muscles.

Some additional equipment purchased:

- A hydrocollator with hot packs for moist heat therapy
- Models of the hip, shoulder, knee and spine to educate patients
  - Weights and a variety of other supplies necessary



for therapy treatment

#### NORMANDIE RIDGE AUXILIARY GENERAL MEMBERSHIP MEETING MONDAY SEPTEMBER 10, 2018

MONDAY, SEPTEMBER 10, 2018 The regular scheduled meeting of the Normandie Ridge Auxiliary was called to order 12:00 Noon September 10, 2018, by President Renee Montag with devotions and prayer. Dinner was served, and introduction of the program was made by Vice President Ray Sistek.

Entertainment was provided by Duane Paul Hannigan with a piano repertoire of pop, sacred, show tunes, classical and original music with some sing-along pieces.

Chad Mondorff, Executive Director of Normandie Ridge then spoke to the membership present on the latest on construction news and other events happening there as follows.

1. Café construction – preparation for the construction has already begun with anticipated demolition starting soon. When completed the new café will double the seating capacity of the current café and will feature amenities like an open kitchen, counter seating and a new menu including some Starbucks options.

2. Cottage Construction: we will begin construction on a new Madison cottage (larger cottage with a garage in the footprint of a former one bedroom and two-bedroom cottage). This will be the second of this type on Normandie Ridge Campus.

3. Planning and preparation of the Apartment building addition continues. We hope to begin pre-sales of the four-story addition to the existing Manchester Apartment building soon.

4. Preliminary work continues on the potential development of the property adjacent to Normandie Ridge and the Westgate Apartments as a Senior Friendly park and walking path.

5. Normandie Ridge is working on collaboration with White Rose Hospice to potentially offer a designated place of respite for Hospice residents and their families on the Normandie Ridge campus.

6. Normandie Ridge is once again participating in an Alzheimer's Walk to support the Alzheimer's Association. In years past the walk conflicted with the Anniversary day celebration. This year we will be hosting our own walk on the Normandie Ridge Campus on September 15<sup>th</sup>.

7. We have been working on cleaning the house on 2030 Roosevelt Avenue to have office space for Albright Care staff working in the York area. Our plan is to develop a show room in part of the house for potential residents to come in and make their selections for their cottage or apartment.

 We have been developing a resource called CareMerge. This is a web-based program that will allow residents and family members to see what is happening at Normandie Ridge along with access to other events in the surrounding area. Currently it has been introduced to the residents and there is an interactive monitor located in the main lobby.
Finally, I want to thank the Auxiliary for all the generous gifts and equipment provided to Normandie Ridge. We are utilizing all the outpatient therapy equipment, enrichment equipment, and Automatic External Defibrillator thanks to your contributions. Additionally, your support of our benevolent care allows us to help those that are no longer able to help themselves financially.

Following the meal and program the meeting was called to order with the Normandie Ridge Prayer. The minutes of the previous meeting were approved on a motion from Lois Baker and second from Jinny Foor.

Treasurer Chuck Martin presented his report noting as of the meeting date there was a balance of \$8,041.18. Income was from Patrons and Business Ads for the 26<sup>th</sup> Anniversary Celebration, Grocery Gift Card Sales, Craft Sales, Membership Dues, Contributions and Memorials. Expenses were additional equipment for the Therapy Department, Memory Care supplies (games and puzzles), postage and supplies. The Treasurer's report was approved on a motion from Barry Montag and second from Lorraine Shindler.

Membership Chairperson Susan Martin presented her report noting the membership drive for 2019 would begin at the upcoming 26<sup>th</sup> Anniversary Celebration to be held October 13, 2018. Currently she noted there are 420 paid members and she had already received \$90 in contributions for the 2019 membership year. Susan noted the \$5.00 dues, contributions, memorial gifts and fundraiser dollars assist the Auxiliary in providing services and equipment that enhance and improve the quality of life for the residents. Funds are also donated to the Benevolent Fund. In total to date the Normandie Ridge Auxiliary has contributed over \$154,000 to support and improve the lives of the residents there.

Enjoy some scenes from the October 13, 2018 Celebration.


